Franklin Township Community School Corporation (FTCSC) is a public school district in Franklin Township, Indiana, comprised of 16 locations, including one high school, two middle schools, 7 elementary schools, and several other learning centers and administrative buildings. With over 10,000 students and more than 1,300 staff, maintaining a safe learning environment and mitigating risk is a huge priority for FTCSC. Recognizing that their security cameras were outdated, the school district worked with security integrator Vermillion Systems. to install a system that offers the capabilities they need to help keep students, faculty and staff safe. By upgrading their solutions, FTCSC sought to gain exceptional image quality, powerful zoom control and longer video retention times to help them strengthen security and avoid the various costs associated with many types of security incidents.

To bring their security system up-to-date, FTCSC deployed ACC<sup>™</sup> video management software, Avigilon Appearance Search and UMD, an Access Control Manager (ACM) system and two servers. The district also installed more than 400 video security cameras, including some models that have embedded self-learning video analytics. These new additions complement the MOTOTRBO two-way radios that FTCSC uses to keep administrators in contact with its police department, allowing them to easily relay information that they gather from their Avigilon video security and access control system to officers so that they can quickly take action.

### **Quick Response to Events on Campus**

Only minutes after FTCSC's Avigilon video security camera system was installed, a suspicious person was detected in a part of campus that they weren't supposed to be in. School administrators immediately used their MOTOTRBO radios to contact the police department so that they could intercept the individual and remove them from campus. Another time, a truck drove onto one of the schools' soccer fields and completely tore up its grass. The Avigilon cameras caught the incident, which provided police with clear video evidence of the vehicle and its route across campus, and helped FTCSC get restitution.


